# ENGLEWOOD AREA FIRE CONTROL DISTRICT

## VOLUNTEER POLICES AND PROCEDURES

### Introduction

This manual is for the **guidance** and **information** of fire department personnel. Its purpose is to give department members complete information regarding the policies and procedures, standard operating guidelines, assignments, and general knowledge for proper conduct and behavior as a Volunteer of the Englewood Fire Department. In service to the public the department member must remember that their **first duty to the citizens of Englewood is the protection of life and property**, and that they are doing something for someone, whether it be rescue, protection of property, or special services.

To perform their duties properly, it is essential that the members of the fire department familiarize themselves thoroughly with all the rules, regulations, and standard operating guidelines pertaining to their positions and to conduct themselves, both on and off duty, in such a manner that will not discredit the department.

The right is reserved to amend or revoke any of the policies, procedures, and standard operating guidelines or to make additional ones as the circumstances or the good of the service may require. No arbitrary rules can be established which will embrace all cases arising in the general discharge of department duties; something must be necessarily left to the intelligence and discretion of the individual.

These procedures are to be followed unless specifically ordered otherwise by a competent authority or in cases where practical application would be contrary to the overall responsibilities and objectives of department policy. In all instances, good judgment, and execution of duties in a fair and impartial manner are paramount.

Anyone deviating from these procedures must be prepared to justify such actions. They will be judged, not in the light of subsequent events but by the situation existing at the time of action.

Members of the Fire Department shall comply with all other rules and regulations as may from time to time be promulgated by the Fire Chief.

### TRAINING AND EDUCATION

Training and education shall be done in accordance with the Englewood Fire Department Training Program.

## **GENERAL DUTIES**

Volunteers shall be responsible for the helmet, coat, boots, pants, gloves, and other equipment issued to them. When membership in the department is terminated, the members shall return all department property in their possession to the fire chief. All equipment must be kept clean and in good order.

Each volunteer of the Fire Department shall obey all policies and procedures of the Englewood Fire Department as well as other applicable local, state, and federal laws.

Each volunteer of the Fire Department shall obey all lawful orders. In the event there is a question of legality of an order, a firefighter shall obey the order and take up the matter with their supervisor. If a firefighter refuses to obey an order, they should be prepared to justify their action.

All volunteers are required to cooperate with one another, not only in the ordinary routine of duty, but also and especially when unusual conditions or special circumstances call for amicable and unreserved cooperation in the general interest.

Volunteers are required to have the necessary knowledge in the operation and use of all firefighting equipment necessary to perform the duties assigned at the scene of a fire, volunteers shall render all necessary assistance to prevent or extinguish fires and prevent loss of property or personal injury. As required or directed, these duties may include but not be limited to:

- A. Operate and use all firefighting equipment including SCBA as needed.
- B. Participate in special events.
- C. Respond to Emergencies.
- D. Participate in Department training.
- E. Assist in station duties.

## **ASSISTANCE**

All volunteers are required to aid another firefighter exposed to danger.

## **MANNER OF ISSUING ORDERS**

Orders from a superior to subordinate shall be in clear and understandable language, civil in tone, and issued in pursuit of departmental business.

## **ADDRESS AND TELEPHONE NUMBERS**

Immediately upon being appointed to the department, members shall inform the administration of their correct address and telephone number. Changes in address or telephone number shall be reported within seven (7) days of such change.

## **DEPARTMENT PROPERTY AND EQUIPMENT**

Volunteers are responsible for the proper care of department property and equipment assigned to or used by them.

### **DAMAGED/INOPERATIVE PROPERTY OR EQUIPMENT**

Volunteers shall immediately report to their commanding officer any loss or damage to department property assigned to them and inform their officer of any defects or hazardous conditions existing in any departmental equipment or property.

### **EQUIPMENT TO BE WORN FOR FIRE SERVICE**

Volunteers, when engaged in emergency service or drills, shall possess and wear regulation fire helmets, coats, bunker pants, boots, and gloves.

### **RULES OF CONDUCT**

A Volunteer of the Fire Department found guilty of any of the following will be considered in violation of the policies and procedures which govern the Fire Department and will be subject to disciplinary action.

1. Conduct which brings discredit upon the Fire Department.
2. Disobedience of an order.
3. Leaving assignment without being properly relieved or without proper authorization.
4. Knowingly make a false report either written or oral.
5. Disseminating or releasing any information contained in a department record except in conformance with Fire Department orders. No information relative to the business or affairs of the Fire Department shall be furnished to persons not connected therewith except as authorized by the Fire Chief.
6. Removing, altering, or changing any official Fire Department record except as authorized by the Fire Chief as directed by superior officer or the Fire Department orders.
7. Obligating the Fire Department financially in any manner except as authorized by the Fire Chief.
8. Being under the influence on intoxicating beverages or illegal drugs while a volunteer of the Englewood Fire Department.

### **DISCIPLINARY ACTION**

Volunteers may be subject to disciplinary action by the Fire Chief for causes as listed:

1. Convicted of a felony
2. Violations of policies and procedures of department after written warning
3. Failure to obey a direct order given by an officer or an officer failing to obey an order by a superior officer
4. Being under the influence of intoxicants while a volunteer.
5. Guilty of insubordination or disgraceful conduct, while in the capacity of a firefighter
6. Offensive in conduct or language in public or towards the public officials while engaged in fire department activities
7. Carelessness or negligent with apparatus and equipment or other property of the department
8. Use of any fire department equipment for personal use

### **Who is subject to Disciplinary Action**

Any volunteer who violates the policies and procedures of the department or who disobeys, and order is subject to appropriate disciplinary action.

### Penalties

The following penalties may be assessed against any member of the department as disciplinary action although not necessarily in the sequence noted:

1. Oral reprimand
2. Written reprimand
3. Suspension
4. Dismissal

### Departmental Authority to Discipline

Final departmental disciplinary authority and responsibility rest with the Fire Chief. For disciplinary purposes, assistant chiefs have the authority to reprimand and may recommend such other disciplinary action as they deem necessary. Charges must be preferred, and a written report of the action taken or recommended given to the fire chief as soon as possible. If the person who has been disciplined so desires, he may apply to the Fire Chief for a hearing.

### Reports of Disciplinary Action Taken or recommended

Whenever disciplinary action is taken or recommended, a written report must be submitted to the fire chief immediately containing the following information:

1. The name, rank, and assignment of the person being disciplined.
2. The date(s) and time(s) of the misconduct and location(s).
3. The item violated.
4. A complete statement of the facts of the misconduct.
5. Disciplinary action imposed or recommended.
6. The written signature and rank of the preparing officer and his position in relation to the member being disciplined.

### Time Requirements

1. The volunteer must do a minimum of 24 hours a month.
2. Volunteers wishing to perform ride time must first contact the Battalion Chief and ask for permission and assignment.
3. No more than one volunteer can ride per station.
4. The volunteer must ride a minimum of 24 hours a month. Time can only be in 12- or 24-hour shifts.
5. Volunteers must participate in at least one (1) drill a month. Drill dates TBD and will be in the evenings. Unless the volunteer participated in a training drill during the day.



## POSITION DESCRIPTION

**Position Title:** Volunteer Firefighter/EMT  
**Department/Division:** Operations  
**Immediate Supervisor:** Lieutenant

### **Position Summary:**

Under general supervision, perform responsible public safety work involving protecting life and property. Respond to alarms and prevent and extinguish fires; respond to rescue calls; respond to medical incidents and render emergency and non-emergency care; engage in fire codes enforcement, public education, station, apparatus, and equipment maintenance activities; and perform related work as required. Respond and assist in the mitigation of technical rescue and hazardous materials incidents. Maintain a constant state of readiness and preparedness for any emergency within the Englewood Area Fire Control District. Duties involve an element of personal danger. This position operates under the supervision of a Company Officer, Division or Group Supervisor, or Incident Commander.

### **Core Expectations:**

- Do Your Job
- Treat people right
- Have an "All In" attitude.
- Give an "All Out" effort.

### **Minimum Qualifications:**

- Must be 18 years of age or older.
- High school graduate or possess a GED Equivalency Certificate.
- Must be able to read, write, and speak English.
- Valid Florida Class E or Commercial Driver's License.
- Must have a safe driving record.
- Valid State of Florida Firefighter II Certificate of Compliance/Minimum Standards
- Valid EMT or Paramedic certification issued by the State of Florida
- Valid CPR-Basic Life Support (BLS) for Health Care Provider or equivalent.
- Valid Advanced Cardiac Life Support (ACLS) or equivalent - Paramedics
- NIMS Incident Command Position Certifications: I-100, I-200, I-700, and I-800.
- Must be tobacco free for at least one year prior to employment.
- Must remain tobacco-free during employment.

**Preferred Qualifications:**

- Associate degree or higher in the Fire Protection discipline or related field.

**Special requirements:**

- Must be able to wear issued safety equipment.

**Essential Job Functions:** (Essential functions, as defined under the Americans with Disabilities Act, may include the following. This list of tasks is ILLUSTRATIVE ONLY and is not a comprehensive listing of all functions and duties performed by people in this position.)

1. Ensures the response readiness and operational reliability of all assigned firefighting, communication, and personal protective equipment.
2. Respond to emergency and non-emergency incidents; provide appropriate services as required, including emergency rescue and fire suppression; perform search and rescue of trapped or injured persons; perform emergency medical and first aid services; prepare reports regarding emergency incidents as assigned.
3. Drives, operates, positions, and spots vehicles and apparatus safely, proficiently, and professionally in emergency and non-emergency situations.
4. Performs firefighting activities, including laying hose and performing fire combat, containment, and extinguishment tasks.
5. Operate numerous types of rescue, emergency, and fire suppression equipment and apparatus as necessary; operate, inspect, repair, and perform other technical tasks related to maintaining apparatus, equipment, and facilities.
6. Participate in cleaning and maintaining facilities, grounds, equipment, and apparatus; making minor repairs; ensuring that appropriate conditions are maintained as assigned facility; ensuring that all equipment and apparatus are in a constant state of readiness for emergency calls.
7. Participates in business pre-fire planning of buildings, hydrants, and other structures.
8. Participate in various fire prevention operations, activities, and programs.
9. Provide fire safety information and educational programs to schools, churches, and civic groups.
10. Position and climb ladders to access buildings' upper levels or assist individuals from burning or unsafe structures.
11. Participates in professional development opportunities and department training exercises.
12. Perform inspection and minor maintenance in fire hydrants.
13. Completes necessary local paperwork, including incident reports; maintains departmental files and records.
14. Maintains health and physical fitness.
15. Performs other related tasks/duties as the chain of command assigns.

## **Job Competencies: Knowledge, Skills & Abilities**

### **Knowledge:**

- Knowledge of department policies and procedures.
- Knowledge of applicable federal, state, and local laws, ordinances, statutes, regulations, rules, policies, and procedures.
- Knowledge of principles, practices, and procedures of modern fire suppression.
- Knowledge of basic emergency medical and life-sustaining techniques, including cardiac care, trauma and shock care, ventilation, and other CPR techniques.
- Knowledge of operation, maintenance, and modern firefighting apparatus and equipment uses.
- Knowledge of fire prevention principles and techniques.
- Knowledge of universal precautions relating to infection control.
- Knowledge of principles, practices, and procedures of hazardous materials.
- Knowledge of radio communications.
- Microsoft Office products and other relevant technologies.

### **Skills:**

- Skilled in driving in emergency and non-emergency situations.
- Skilled in operating all firefighting, rescue, and medical equipment.
- Skilled in the application of emergency medical service techniques.
- Skilled in extrication techniques and equipment.
- Skilled in oral and written communications.
- Skilled in preparing written reports.
- Skilled in the use of a computer.
- Skilled in effective time management.
- Skilled in problem-solving and troubleshooting.

### **Abilities:**

- Ability to perform complex and dangerous work under emergency hazardous conditions.
- Ability to think and act quickly and efficiently in emergencies.
- Ability to work as a member of a team.
- Ability to remain calm & interact effectively with members of the public under stressful situations.
- Ability to select and use appropriate equipment and apparatus for emergencies.
- Ability to apply firefighting techniques and procedures.
- Ability to read maps and provide travel directions.
- Ability to understand and follow oral and written directions promptly and accurately.
- Ability to communicate both verbally and in writing.
- Ability to provide superior customer service for both internal and external customers.
- Ability to establish and maintain effective working relationships with co-workers, supervisors, and the public.
- Ability to perform strenuous or peak physical activities during emergencies, training, or station maintenance for prolonged periods under extreme conditions such as heights, intense heat,



cold, or smoke.

**Physical Demands:**

The work is typically performed while sitting, standing, walking, bending, crouching, or stooping. At emergency scenes, the member must lift light, heavy, and very heavy objects, climb many types of ladders, and use tools and equipment requiring a high degree of dexterity.

Must be able to:

- Wear and operate Self Contained Breathing Apparatus (SCBA), mask, and other protective equipment in hazardous and confined spaces independent of other members.
- Wear various uniforms, vests, and equipment weighing up to 45 lbs.
- Push manually with an average force of 73.3 lbs.
- Pull manually with an average force of 96 lbs.
- Climb through small openings and crawl or maneuver in confined spaces.
- Work in hazardous work areas and medical/trauma situations, which may involve death, dismemberment, or exposure to bodily fluids and hazardous materials.
- Rapidly go from stationary to maximum exertion.

**Strength:** Very Heavy

Exerts over 100 lbs. of force occasionally, over 50 lbs. of force frequently, or over 20 lbs. of force constantly to move objects. Physical demands are more than those for heavy work.

**Movement:**

- Occasionally – standing, climbing, balancing, crawling, fine finger manipulation, squatting, kneeling, stooping, trunk bending, backward bending.
- Frequently – sitting, walking; uneven terrain; climbing; forward, horizontal, and overhead reaching; forceful gripping; trunk twisting; cervical flexion, extension, rotation, and lateral flexion.
- Constantly – overhead reaching.

**Auditory** – not limited.

- Talking and hearing

**Vision:** - Required

- Near acuity, far acuity, depth perception, adjustment, color vision, field of vision.

**Sensory:**

- Requires color perception and discrimination.
- Requires sound perception and discrimination.
- Requires taste perception and discrimination.
- Requires odor perception and discrimination.

- Requires depth perception and discrimination.
- Requires texture perception and discrimination.
- Requires visual perception and discrimination.

**Work Environment:**

**Environmental Conditions and Physical Surroundings –**

- Occasional – exposure to weather, extreme hot or cold, wet and/or humid, vibration, hazards, confined/restricted working environment.
- Frequent – extreme heat/fire, noise, atmospheric conditions.

**Equipment Utilized**

- Telephone, protective equipment, automobile, calculator, radio, adding machine, video equipment, pager, portable telephone, fax machine, IAP worksheets, personnel accountability systems, familiarity with tools and equipment utilized in fire suppression, technical rescue, and hazardous materials incident response.

**Hazards**

- Rare – proximity to moving, mechanical parts; exposure to electrical shock; working with explosives.
- Occasional – working in high, exposed places; exposure to radiant energy; exposure to caustic chemicals; exposure to bloodborne pathogens; exposure to infectious diseases, increased risk of cancer.
- Frequent – exposure to dust, fumes, gases, or airborne particles; working in roadways or construction zones.
